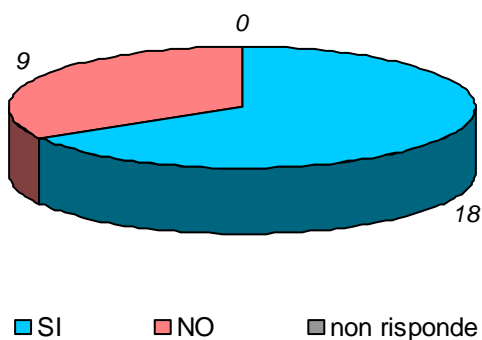

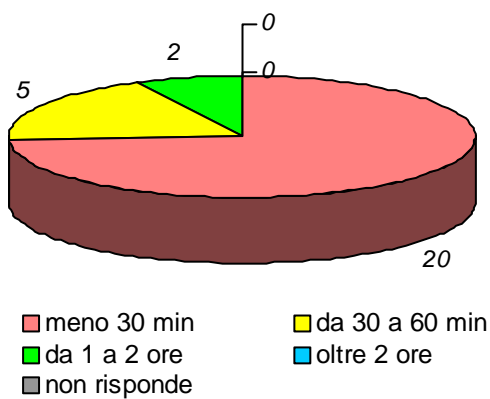
domanda 9: percentuale di frequenza della disciplina
